

# Sonoma County 4-H Camp Club Staffer Payment Schedule

Staffer Fees: \$200.00

4-H Enrollment Fees: \$63.00 for youth not enrolled in another club

**The first payment is 25% due with your Staffer application. 25% of \$200= \$50.00** You must be enrolled into 4-H in order to be able to attend camp. The 4-H enrollment fee for the year is \$63.00.

If you are joining 4-H (not in another 4-H club) your payment will be \$63.00 +\$50.00=\$113.00

**The balance must be paid in full by February 1<sup>st</sup>. (NO EXCEPTIONS!)**
